OPINION AND FINDINGS

On December 21, 2005, Steven L. Devening dba Devening Trucking, Tekamah, Nebraska, filed an application to establish limousine rates for its use as follows:

Description	Proposed Rates
I. Standard Service	
(a) Up to one hour:	\$80.00
(b) Up to two hours:	\$75.00 per hour or fraction thereof (inclusive of the first hour; and
(c) In excess of two hours:	\$65.00 per hour or fraction thereof (inclusive of the first two hours)

Charges apply from time of dispatch until time of return of vehicles to base.

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate B-1670. The certificate authorizes the transportation of passengers and their baggage by limousine between points in Burt County, on the one hand, and, on the other hand, points in Nebraska. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. All trips must originate in Burt County. The proposed rates are necessary to cover operating costs of the applicant. They are also believed to be sufficient to produce a reasonable profit after the operating expenses and still maintain a quality service.

Applicant recently received authority to provide limousine service within its defined area. The proposed rate is competitive with other carriers providing a similar service with like equipment. The application is filed in compliance with Sections 75-308 (Rates) and 75-121 (Emergency rate orders), R.R.S. 2003 and the Commission rules.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective January 13, 2006.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective January 13, 2006, Steven L. Devening dba Devening Trucking, Tekamah, Nebraska, be, and it is hereby, authorized to establish rates for its use as follows:

Description	Proposed Rates
I. Standard Service	
(a) Up to one hour:	\$80.00
(b) Up to two hours:	\$75.00 per hour or fraction thereof (inclusive of the first hour; and
(c) In excess of two hours:	\$65.00 per hour or fraction thereof (inclusive of the first two hours)

Charges apply from time of dispatch until time of return of vehicles to base.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in the Daily Record, Omaha, Nebraska, pursuant to the provisions of Section 75-121, R.R.S. 2003, and the Commission's rules.
