On January 27, 2006, Kyle Halsey d/b/a Heartland Limousine, Beatrice, Nebraska filed an application for authority to establish limousine rates for its use as follows:

<u>Description</u>	<u>Proposed Rates</u>
1. 1991 120" stretch limousine:	
a. Up to two (2) hours	\$180.00
b. Each additional hour thereafter	\$ 50.00
2. 1998 120" stretch limousine:	
a. Up to Two (2) hours	\$250.00
b. Each additional hour thereafter	\$ 90.00
3. An additional charge of \$30.00 will apply to trips originating more than thirty (30) miles from carrier's facility at Beatrice, Nebraska	

Emergency action is requested

Applicant is a certificated common carrier which holds Certificate B-1664. The certificate authorizes the transportation of passengers by limousine service between points in Gage and Jefferson counties. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.

The Commission finds that the proposed rates are fair and reasonable for the type of services rendered. The Commission further finds that the rates are similar and competitive to those charges by other carriers who provide a similar service.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective February 24, 2006.

a. Up to two (2) hours	\$180.00
b. Each additional hour thereafter	\$ 50.00
2. 1998 120" stretch limousine:	
a. Up to Two (2) hours	\$250.00
b. Each additional hour thereafter	\$ 90.00
3. An additional charge of \$30.00 will apply to trips originating more than thirty (30) miles from carrier's facility at Beatrice, Nebraska
