On December 14, 2006, Darin P. VanNatter dba Prestige Limo, Sidney, Nebraska filed an application for authority to establish limousine rates for its use as follows:

2.0 hours	\$190.00
3.0 hours	\$235.00
Each hour after three hours	\$45.00
1997 Black Lincoln 6 Passenger Limousine:	
1.0 hours	\$80.00
2.0 hours	\$160.00
3.0 hours	\$200.00
Each hour after three hours	\$40.00

Note 1. All rates have a minimum one hour requirement.

Note 2. There is no additional charge for mileage.

Emergency action is requested.

The Applicant is a certificated common carrier which holds Certificate B-1688, which authorizes the transportation of passengers and their baggage in limousine service between points in Cheyenne County, and between points in said county on the one hand, and, on the other hand, points in Nebraska over irregular routes. All trips will originate and terminate in Cheyenne County. The transportation of railroad train crews and their baggage would not be authorized. The Applicant received

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective December 22, 2006, OMALink, Inc., Lincoln, be, and it is hereby, authorized to establish limousine rates for its use as follows:

Each hour after three hours	\$40.00
