On March 1, 2007, James and Rhonda Joneson dba Leisure Limousine and Sedan Service, Lincoln, Nebraska filed an application for authority to establish limousine rates for its use as attached in Schedule A.

Emergency action is requested.

The Applicant is a certificated common carrier which holds Certificate B-1685, which authorizes the transportation of passengers in Nebraska intrastate commerce to provide limousine service in sedan and luxury or stretch limousines between points in Douglas, Sarpy, Lancaster and Washington counties over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The Applicant received authority to operate from the Commission under Certificate No. B-1685, on February 27, 2007.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 9, 2007.

O R D E R

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective March 9, 2007, James and Rhonda Joneson dba Leisure Limousine and Sedan Service, Lincoln, Nebraska, be, and it is hereby, authorized to establish limousine rates for its use as set for the in Schedule A attached hereto.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in The Daily Record, Omaha, Nebraska pursuant to the provisions of Section 75-121, R.R.S. 2003, and the Commission's rules.
