On March 27, 2007, Karl Riggs dba Kountry Limousine Bennington, Nebraska filed an application for authority to establish limousine rates for its use as follows:

<u>Service</u>	<u>Proposed Rate</u>
Limousine Service	\$75.00 per hour

Emergency action is requested.

The Applicant is a certificated common carrier which holds Certificate B-1689, which authorizes the transportation of passengers in Nebraska intrastate commerce in limousine service between points in Douglas, Washington and Dodge counties and between points in said counties over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The Applicant received authority to operate from the Commission under Certificate No. B-1689, on March 20, 2007.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 9, 2007.

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective April 6, 2007, Karl Riggs dba Kountry Limousine, Bennington, Lincoln, be, and it is hereby, authorized to establish limousine rates for its use as follows:
