OPINION AND FINDINGS

On September 6, 2007, Luxury Limousine Service, Syracuse, filed an application for authority to amend its existing rates through an increase in its rates from zero to thirty percent and establish rates for a 2007 Chevrolet Suburban 14 passenger limousine.

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate B-1554. The certificate authorizes the transportation of passengers and their baggage by limousine service in certain counties in southeast Nebraska.

The Applicant last received an increase in its rates in July of 2005. Since that time, the Applicant has experienced increases in its cost of doing business. Insurance rates have risen ten percent. The price of gasoline has also increased from \$2.40 per gallon in 2005 to almost \$3.00 per gallon as of the time of the entry of this order. Maintenance costs have also risen due to increasing oil costs.

The drivers of the Applicant are employees, who receive an hourly wage from the Applicant as well as tips received from customers. These drivers as well as other employees have been given pay raises, and the Applicant plans to continue to raise its hourly wage. In addition, the Applicant plans to add more drivers as its business increases. The Applicant has also added a storage facility for its limousines in order to protect the fleet from the weather and keep them in good condition.

The proposed rates are similar and competitive with those rates authorized for use by other companies providing a similar

service in its area. The Commission finds that these rates are reasonable. The Commission also finds that the rates should be approved on an emergency basis due to the recent increase in gasoline costs that needs to be addressed in an emergency manner.

Considering the amount of time since the Applicant's rate increase, and the increase in other cost factors, the increases requested by the Applicant are reasonable. The proposed rates are competitive with other limousine companies operating in the area. The application is filed in compliance with Sections 75-308 (Rates) R.R.S. 2006 and 75-121 (Emergency Rate Orders) and the Commission rules.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective September 28, 2007.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that DJW, Inc., d/b/a Luxury Limousine, Syracuse, Nebraska, be, and it is hereby, authorized to amend its limousine rates effective September 28, 2007, as per the attached rate schedule which by reference hereto becomes a part hereof.
