Funeral Prices: \$50 per hour with two hour minimum up to eight passengers.

Book six hours and get seventh hour free.

Book Ten hours and get two free hours.

A fuel fee of \$20.00 will be charged for cities over 70 miles from home base (Tekamah).

Deposit of one-half (1/2) down when booking is required.

Emergency action is requested.

The Applicant is a certificated common carrier which holds Certificate B-1715, which authorizes the transportation of Transportation of passengers and their baggage in limousine service between points within a 100 mile radius of Tekamah, Nebraska. RESTRICTIONS: All rides must originate north of the county line separating Washington and Douglas County, Nebraska, Said line shall extend to the western border of the certificate's territory. The transportation of railroad train crews and their baggage is not authorized. HHS designation: No. The Applicant was granted the authority on January 6, 2009, and this is its initial application for rates under this certificate.

The proposed rates cover six and eight passenger limousines. There is a special rate for use in a funeral. There is also a fuel surcharge of \$20.00 per trip requested that applies to trips that oar in cities that are over seventy miles from their home base of Tekamah.

The Applicant represents to the Commission that the proposed rates are based upon the expenses the Applicant will incur in the operation of the bus as well as a reasonable profit. The Applicant states that its proposed rates are competitive with other rates charged by similarly situated providers.

The application should be approved on an emergency basis as this is the first rate application for the recently granted authority. A denial of the application on an emergency basis would result in at least a months delay in the start-up of operations. The Applicant has already made an investment in its operation and needs to begin to operate as soon as possible.

The proposed rates are competitive with those rates authorized for use by other companies providing a similar service in its area. The Commission finds that these rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective April 10, 2009.

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective April 10, 2009, A Superior Limousine Inc., Tekamah, Nebraska, be, and it is hereby, authorized to establish its rates for its use as follows:
