OPINION AND FINDINGS

On March 3, 2009, Luxury Limousine Service, Syracuse, filed an application for authority to amend its existing rates through an increase in its rates from ten to twenty percent.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on April 13, 2009, pursuant to the Commission's rules. The application was not protested.

Applicant is a certificated common carrier which holds Certificate B-1554. The certificate authorizes the transportation of passengers and their baggage by limousine service in certain counties in southeast Nebraska.

The Applicant last received an increase in its rates in September of 2007. Since that time, the Applicant has experienced increases in its cost of doing business. Insurance rates have risen five percent. The price of gasoline has also increased back into the \$2.60 range from \$2.00 per gallon in early 2009. Operating costs have increased seven percent due to utility and rent increases.

Salaries for employees have increased over \$1.00 per hour for drivers. The applicant is planning to give another \$0.70 in the coming year. The applicant has also added six part-time employees. The applicant has also instituted a drug testing program for its staff, which has added additional costs. A Special Employee has been hired to ensure compliance with DOT rules as well as keep up on safety issues.

The applicant is also considering the purchase of two more vehicles to add to its fleet. The goal of the additional vehicles are to improve the fleet as well as enhance the service provided.

The proposed rates are similar and competitive with those rates authorized for use by other companies providing a similar service in its area. The Commission finds that these rates are reasonable. Considering the increase in other cost factors, the increases requested by the Applicant are reasonable. The proposed rates are competitive with other limousine companies operating in the area. The application is filed in compliance with S 75-308 (Rates) R.R.S.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective July 3, 2009.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that DJW, Inc., d/b/a Luxury Limousine, Syracuse, Nebraska, be, and it is hereby, authorized to amend its limousine rates effective July 3, 2009, as per the attached rate schedule which by reference hereto becomes a part hereof.
