O P I N I O N S A N D F I N D I N G S

On March 23, 2009, Leisure Limousine and Sedan Service, Inc., Lincoln, Nebraska filed an application for authority to amend current rates as attached.

Emergency action is requested.

The Applicant is a certificated common carrier which holds Certificate B-1718, which authorizes the transportation of passengers in Nebraska intrastate commerce to provide limousine service in sedan and luxury or stretch limousines between points in Douglas, Sarpy, Lancaster and Washington counties over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized.

The proposed changes would fold the fuel surcharge into the rates as well as increase the base rates from between zero to nine percent. It would also impose a mileage fee for trips that originate 40 miles or more from Lincoln. The impact of the proposed changes varies due to the length of the scheduled trip as well as the size of the vehicle.

The applicant cited increases in personnel costs, insurance costs, and storage costs as the major factors behind the request. The Applicant represented to Commission staff that it experienced an increase of 21 percent in insurance, 9 percent in personnel and 33 percent in storage costs. These increases are significant enough that they have a negative impact on the operations of carriers such as the Applicant. The Commission finds that the cost increases justifies the granting of this application on an emergency basis.

The proposed rates are similar and competitive with those rates authorized for use by other companies providing a similar service in its area. The Commission finds that these rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective April 17, 2009.

O R D E R





