The certificate allows the transportation of passengers in limousine service in vintage sedan automobile by appointment between points in Lancaster, Otoe, Cass, Sarpy, Saunders, Dodge, Cuming, Wayne, Dixon, Douglas, Washington, Burt, Thurston, and Dakota counties, and between points in said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate No. B-1760 on June 22, 2010. The Applicant is establishing rates for these particular vehicles for use in this certificate.

The Applicant represents to the Commission that the proposed amended rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates are competitive with similar rates charges by other services for these types of vehicles.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved.
