OPINION AND FINDINGS

On November 5, 2010, Groetken Company d/b/a Prince and Princess Limousine, Sioux City, Iowa, filed an application for authority to establish the following rates for its use in its operations (see attached Schedule 1).

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate No. B-1698. The certificate allows the transportation of passengers and their baggage by luxury sedan limousine only between points in Dakota, Thurston, Cuming, Burt, Wayne, Cedar and Dixon counties, and between points within said counties on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The transportation of Health and Human Services clients, and clients of contractors, such as Options, Partners and Curtis & Associates is not authorized.

The Applicant received authority to operate from the Commission under Certificate No. B-1698 on May 27, 2009. The Applicant is establishing rates for these particular vehicles for use in this certificate.

The Applicant represents to the Commission that the proposed amended rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates are competitive with similar rates charges by other services for these types of vehicles.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved.
