OPININON AND FINDINGS

On February 4, 2011, T & T Limousine Service, LLC, Fremont, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Description	Proposed
Per Hour (3 hour minimum)	\$100.00
Wait time (up to 1½ hours)	\$50.00

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate Number B-1783. The certificate allows the transportation of passengers by luxury or stretch limousine between points in Dodge, Washington, Saunders, Cuming and Colfax counties over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate No. B-1783 on February 8, 2011. The Applicant is establishing rates for use in this certificate.

The Applicant represents to the Commission that the proposed amended rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates are competitive with similar rates charges by other services for these types of vehicles.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin

operations under its certificate as granted until the rates are approved.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective February 11, 2011.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective February 11, 2011, T & T Limousine Service, LLC, Fremont, Nebraska, be, and it is hereby, authorized to establish rates for the following vehicles its use as follows:

Description	Rate
Per Hour (3 hour minimum)	\$100.00
Wait time (up to 1½ hours)	\$50.00
