Applicant is a certificated common carrier which holds Certificate Number B-1757. The certificate in Supplement 4 allows the transportation in Nebraska intrastate commerce in the transportation of passengers and their baggage in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant represents to the Commission that the proposed amended rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates are

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective September 2, 2011.
