OPININON AND FINDINGS

On August 18, 2011, Nightlife Limousine, LLC, Beatrice, Nebraska, filed an application for authority to establish rates for its use in its operations in Supplement 4. The applicant proposes the following application:

Applicant is a certificated common carrier which holds Certificate Number B-1757. The certificate in Supplement 4 allows the transportation in Nebraska intrastate commerce in the transportation of passengers and their baggage in charter and special party service between all points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate No. B-1757, Supplement 4 on March 30, 2010. The Applicant is establishing rates for these particular vehicles for use in this certificate.

The Applicant represents to the Commission that the proposed amended rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates are
