OPINION AND FINDINGS

On April 19, 2012, Limousine Services, LLC, Lincoln, Nebraska, filed an application for authority to establish rates for its use in its sedan operations and to add a fuel surcharge to its current rates. The Applicant proposes the following rates:

Standard Sedan Service:	\$79.00/hour

Sedan service as continuation of limousine services (i.e. "getaway car" for bride and groom)	\$59.00/hour

Fuel Surcharge:

\$3.50 - \$3.75	9%

\$4.27 - \$4.50	12%

\$5.01 - \$5.25	15%

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate Number B-1761. The certificate allows the transportation of passengers by luxury limousine between points within a 250-mile radius of Dakota City over irregular routes. RESTRICTION: 1) The transportation of railroad train crews is not authorized; and 2) The certificate holder shall maintain a listing of its services in the Yellow Pages of the telephone directory serving Dakota City.

The Applicant received authority to operate with sedans from the Commission under Certificate No. B-1761 on April 17, 2012. The Applicant is establishing rates for these vehicles for use in this certificate, and is proposing a change in the fuel surcharge as applied in its operations.

The Applicant represents to the Commission that the proposed amended rates are based upon an informal market study of the rates for similar service charged by other providers of a similar service. The Applicant believes that the proposed rates will allow them to compete in the marketplace as well as provide an adequate rate of return.

The Commission finds that the rates as proposed by the Applicant are similar to and competitive with the rates charged by other services for these types of vehicles. The fuel surcharge is also similar to charges held by other providers.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin to operate with its sedans until the Commission has approved rates for the Applicant.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective April 27, 2012.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective April 27, 2012, Limousine Service, LLC, Lincoln, Nebraska, be, and it is hereby, authorized to amend rates for the following vehicles its use as follows:

Each hour over five hours	\$47.50/hr
2 hour split time (1+1)	\$240.00
4 hour split time (2+2)	\$430.00

Rates are based upon a two hour minimum
Time begins when the limo arrives at the pick-up location
Split times are based on a three hour minimum wait time with a single split allowed.

Standard Rates (10 passenger):

First Five Hours	\$105.00/hr
Each hour over five hours	\$52.50/hr
2 hour split time (1+1)	\$260.00
4 hour split time (2+2)	\$470.00

Rates are based upon a two hour minimum
Time begins when the limo arrives at the pick-up location
Split times are based on a three hour minimum wait time with a single split allowed.

Wedding Package (either limousine)

First Hours	\$200.00
Two hours	\$300.00
Three hours	\$400.00
Four hours	\$500.00
Each hour over four hours	\$ 75/hr

Time begins when the limo arrives at the pick-up location


