BY THE COMMISSION:

On May 29, 2013, Elite Limo of Omaha, LLC, Omaha, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Description	Proposed
One Hour	\$125
Two Hours	\$100/hour
Three Hours	\$90/hour
Four Hours	\$80/hour

Emergency action is requested.

O P I N I O N A N D F I N D I N G S

Applicant is a certificated carrier which holds Certificate Number B-1826. The certificate authorizes the transportation of passengers by luxury or stretch limousine between points in a 100 mile radius of Omaha, and between points in the 100 mile radius, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. Point-to-point transportation within Lancaster County is not authorized. Restricted to stretch limousines of eight passengers or more. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate Number B-1826 on June 4, 2013. The Applicant is establishing its rates for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the Application on an emergency basis. The Commission further finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective June 14, 2013.

O R D E R

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective June 14, 2013, Elite Limo of Omaha, LLC, Omaha, Nebraska, be, and it is hereby, authorized to establish rates for its use as follows:

Description	Rate
One Hour	\$125
Two Hours	\$100/hour
Three Hours	\$90/hour
Four Hours	\$80/hour
