Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate Number B-1761. The certificate allows the transportation of passengers by luxury limousine between points within a 250-mile radius of Dakota City over irregular routes. RESTRICTION: 1) The transportation of railroad train crews is not authorized; and 2) The certificate holder shall maintain a listing of its services in the Yellow Pages of the telephone directory serving Dakota City.

The Applicant represents to the Commission that the proposed changes in its rates are based upon current market trends as well as the experience of the Applicant with its business bookings. The rates are anticipated to be competitive with other companies providing a similar service.

The primary changes in the rates are a reduction in the standard sedan rates, the establishment of rates for a 12 passenger limousine, the addition of all day rentals for some of its vehicles, and the establishment of a Buy One Get One Free (BOGO) program. In addition, the fuel surcharge rate has been reduced two percentage points.

In applications such as these, the Commission must find that an emergency situation exists. In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant should be placed in a position to use these rates in its operations so as to place itself in a competitive position. The Commission further finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective August 8, 2014.

#### ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Limousine Services, LLC, Lincoln, Nebraska,, Nebraska, be, and it is hereby, authorized to establish rates for its services on an emergency basis effective August 8, 2014, as follows:




