BY THE COMMISSION:

On April 27, 2015, Blue Collar Limo, LLC, Bayard, Nebraska, filed an application for authority to establish a rate for a new vehicle to be used in its operations as follows:

Description	Proposed
2003 Cadillac Escalade	
First Two Hours (two hour minimum)	\$350.00
Hours after first two	\$100.00
Mileage charge to and from pick-up location	\$1.00/mile

Deposit of \$250.00 due at booking. Deposit is refundable if cancelled at least five days prior to the date of service.

Emergency action is requested.

O P I N I O N   A N D   F I N D I N G S

Applicant is a certificated carrier which holds Certificate Number B-1838. The certificate authorizes the transportation of passengers by limousine in Morrill, Scotts Bluff, Banner, Kimball, Cheyenne, Garden, Box Butte, Sheridan and Sioux counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

The Applicant received authority to operate from the Commission under Certificate Number B-1838 on July 9, 2013. The Applicant is establishing a rate for a new vehicle, a 2003 Cadillac Escalade, for use in this certificate. The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. rate for the current vehicle, a Chevrolet Avalanche, is to remain unchanged.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin to use the new vehicle under its certificate until the rate is approved. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the Application on an emergency basis. The Commission further finds that the proposed rate is reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective May 8, 2015.

O R D E R

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective May 8, 2015, Blue Collar Limo, Bayard, Nebraska, be, and it is hereby, authorized to establish rates for its use as follows:

Description	Rate
2003 Cadillac Escalade:	
First Two Hours (two hour minimum)	\$350.00
Hours after first two	\$100.00
Mileage charge to and from pick-up location	\$1.00/mile
Chevrolet Avalanche:	
First Two Hours (two hour minimum)	\$250.00
Hours after first two	\$60.00
Mileage charge to and from pick-up location	\$0.50/mile

Deposit of \$250.00 due at booking. Deposit is refundable if cancelled at least five days prior to the date of service.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in the Daily Record, Omaha, Nebraska, pursuant to the provisions of Section 75-121. R.R.S. 2014, and the Commission Rules.
