On September 1, 2016, Premier Limousine, LLC ("Applicant"), Broken Bow, filed an application for authority to establish its rates as follows:

Applicant is a certificated carrier that holds Certificate Number B-1922. The certificate authorizes the transportation of passengers by luxury or stretch limousine and sedan in Custer, Lincoln, Dawson, Buffalo, Sherman, Valley, Garfield, Loup, Blaine, Thomas, Logan, and Holt counties, on the one hand, and on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no. Applicant acquired the authority, through transfer, the operating rights granted to Destinations d/b/a Chauffeured Services, LLC, Broken Bow, in Certificate B-1916. The transfer was granted on September 7, 2016.
