OPINION AND FINDINGS

On March 3, 2017, Leisure Limousine and Sedan, Inc. ("Applicant"), Lincoln, filed an application for authority to amend its rates as follows:

Emergency action is requested.

Applicant is a certificated carrier that holds Certificate Number B-1718. The certificate authorizes the transportation of passengers and their baggage by limousine service in sedan and luxury or stretch limousines between points in Douglas, Sarpy, Lancaster, and Washington Counties over irregular routes. Supplement 1 authorizes limousine services by luxury and stretch limousine and sedan between points in Douglas, Sarpy, Lancaster, Washington, Saunders, Seward and Cass Counties, and between said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. Supplement 2 allows for transportation of passengers in limousine service by luxury and stretch limousine and sedan and van between points in York and Gage counties, and between said counties, on the one hand, and,

on the other hand, points in Nebraska over irregular routes. Supplement 4 authorizes open class by van and SUV between points in Douglas, Sarpy, Cass, Saline, Gage, Otoe, York, Hamilton, and Hall Counties, and between said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is no. The original authority was granted on February 17, 2009, and the most recent Supplement was granted on March 28, 2017.

Applicant last received a rate increase in July 2011. In its application, Applicant states that it is seeking to make its limousine rates accurately reflect the services requested by its customers, such as adding an hourly rate. The limousine rates are being revamped to show general limousine rates, as opposed to specific rates for specific vehicle types. The limousine rates are also no longer differentiated between events, such as weddings, and standard rates. In addition, Applicant has added rates for airport shuttle service, which is a new service under its open class authority supplement approved by the Commission in its March 28, 2017 order. The Commission finds that the proposed rates are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as Applicant cannot begin to use the proposed rates until the Commission approves the application. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 28, 2017.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Leisure Limousine and Sedan, Inc., Lincoln, be, and it is hereby, authorized to amend its rates for its services on an emergency basis effective March 28, 2017, as follows:
