OPINION AND FINDINGS

By application filed December 21, 1989, T.V.B. Movers, Inc., Lincoln, Nebraska seek to acquire the authority as a common carrier in Nebraska intrastate commerce granted to Thomas Von Busch, dba T.V.B. & Co. Movers, in Certificate M-13252. Notice of the application was published in the Daily Record, Omaha, Nebraska on December 22, 1989 pursuant to the rules of the Commission.

Since no protests were filed, Application No. M-13631 was processed pursuant to Rule 018.03 of the Rules and Regulations of the Nebraska Public Service Commission pertaining to notice.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

- 1. Applicant is fit, willing, and able properly to perform the proposed service.
- 2. That the proposed transfer of operating rights will be consistent with the public interest and will not unduly restrict competition.
- That the certificate issued in Application No. M-13252, is not dormant.
- 4. That a certificate should be issued in Application No. M-13631, authorizing the following operations:

Transportation of household goods and office equipment. Between points in Nebraska over irregular routes.

5. That the certificate issued in Application No. M-13252 should be revoked and cancelled.

ORDER

IT IS THEREFORE, ORDERED by the Nebraska Public Service Commission that Application No. M-13631 be, and it is hereby, granted; and that a certificate of public convenience and necessity shall be issued to T.V.B. Movers, Inc., in Application No. M-13631 authorizing the operations set forth in the foregoing findings and that to avoid a lapse in authority, the certificate issued in Application No. M-13252 shall be revoked and cancelled simultaneously with the issuance of a certificate of public convenience and necessity in Application No. M-13631.

IT IS FURTHER ORDERED that applicant shall not be issued the certificate of public convenience and necessity authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Sections 75-305 (Fees), 75-307 (insurance), and 75-308 (Rates), R.R.S. 1943, as amended, and with the Rules and Regulations of the Commission; and if upon expiration of such time, applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a certificate of public convenience and necessity is issued.

IT IS FURTHER ORDERED that the certificate of public convenience and necessity authorized shall be subject to the terms, conditions, and limitations which have been, or may hereafter be, prescribed by the Commission.
