OPINION AND FINDINGS

By application filed April 2, 1998, Graebel/Kansas City Movers, Inc., dba Graebel/Omaha Movers, hereinafter referred to as applicant, seeks approval of the acquisition of the operating rights and authority granted to Herman Bros., Inc., dba Transwood, in Certificate M-10371, which authorizes:

SERVICE AND TERRITORY AUTHORIZED:

COMMON: Household goods between all points in Nebraska over irregular routes.

In its application, applicant further requested that this Commission grant temporary approval to the applicant of a lease of the motor carrier properties and the certificate sought to be acquired by it. Notice of such request for temporary authority was published in The Daily Record, Omaha, Nebraska, on April 6, 1998, pursuant to the rules and regulations of this Commission.

It appears that failure to grant temporary approval may result in destruction of or injury to such motor carrier property and the certificate sought to be acquired, or interfere substantially with their future usefulness in the performance of adequate and continuous service to the public.

Such temporary approval should be granted for ninety (90) days from the effective date of this Order pursuant to Neb. Rev. Stat., Section 75-319, (Reissue 1996).

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that the application for approval of a lease of the motor carrier properties and the certificate sought to be acquired by Graebel/Kansas City Movers, Inc., dba Graebel/Omaha Movers, be, and it is hereby, granted to the applicant for ninety (90) days from the effective date of this Order.
