OPINION AND FINDINGS

By application filed April 13, 1998, Hot Shot Deliveries L.L.C., Omaha, hereinafter referred to as applicant, seeks a Contract Carrier Permit as a contract carrier of property by motor vehicle as follows:

AUTHORITY SOUGHT

Household goods between points in Nebraska over irregular routes under continuing contract(s) with the Nebraska Furniture Mart.

Notice of the application was published in <u>The Daily Record</u>, Omaha, Nebraska, April 15, 1998, pursuant to the rules of the Commission.

Since no protest was filed, Application M-14152 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Application M-14152 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Contract Carrier Permit shall be issued to Hot Shot Deliveries L.L.C., Omaha, in Application M-14152, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that applicant shall not be issued the Contract Carrier Permit authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat., Sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates), (Reissue 1996), and with the rules and regulations of the Commission; and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a Contract Carrier Permit is issued.

IT IS FURTHER ORDERED that applicant shall render reasonably continuous and adequate service to the public pursuant to the authority authorized.

IT IS FURTHER ORDERED that the Contract Carrier Permit authorized shall be subject to the terms, conditions, and limitations which have been, or may hereafter be, prescribed by the Commission.
