## OPINION AND FINDINGS

By application filed on February 21, 2002, Albert McClain dba Al's Hauling & Moving Co., Omaha, hereinafter referred to as applicant, seeks a Certificate of Public Convenience and Necessity to operate as a common carrier of household goods by motor vehicle as follows:

## AUTHORITY SOUGHT

## CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

COMMON: Transportation of household goods between points in Douglas County over irregular routes.

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that Application No. M-14171, be, and it is hereby granted; and that upon compliance with terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Albert McClain dba Al's Hauling & Moving Co., Omaha, Nebraska, in Application M-14171 authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that applicant shall not conduct the operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that applicant shall render reasonably continuous and adequate service to the public pursuant to the authority authorized.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity authorized shall be subject to the terms, conditions, and limitations which have been, or may hereafter be, prescribed by the Commission.
