BY THE COMMISSION:

On June 29, 2018, Senior Moving Services, LLC, d/b/a Senior Moving Services, Valley, Nebraska, filed an application seeking authority to amend its Certificate of Public Convenience and Necessity by extending its authority to operate statewide in Nebraska and removing a restriction that requires Applicant to use only vehicles with a Gross Vehicle Weight Rating of 9,000 pounds or less.

Notice of the application was published in The Daily Record, Omaha, Nebraska on July 16, 2018. Because no protests were filed, Application M-14190, Supplement 1, was processed pursuant to Rule 018.03 of the Commission Rules of Procedure.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able to properly perform the proposed service, and to conform to the provisions of Neb. Rev. Stat., sections 75-301 to 75-322, (Cum. Supp. 2016), and the requirements, rules and regulations of the Commission thereunder.
2. The proposed intrastate service is or will be required by the following extent:

3. The application to amend authority should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application M-14190, Supplement 1 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, an amended Certificate of Public Convenience and Necessity shall be issued to Senior Moving Services, LLC, Valley, Nebraska, in Application M-14190, Supplement 1, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that applicant shall not be issued the amended Certificate authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates)(Cum. Supp. 2016), and with the rules and regulations of the Commission, and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a Certificate is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations that have been, or may hereafter be prescribed by the Commission.
