OPINION AND FINDINGS

By application filed September 21, 2007, Flat Rate Movers, LLC, Elkhorn, hereinafter referred to as applicant, seeks a Permit to operate as a common carrier of household goods by motor vehicle as follows:

AUTHORITY SOUGHT

Transportation of household goods within the state of Nebraska by truck over irregular routes.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on October 1, 2007, pursuant to the rules of the Commission.

Because no protests were filed, Application M-14199 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

ORDER

Stat. sections 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 2003), and with the rules and regulations of the Commission, and if upon expiration of such time applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a Permit is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
