BY THE COMMISSION:

On October 2, 2009, an application was filed by The Billings Group, d/b/a Quick City Delivery ("Applicant"), Omaha, seeking authority to acquire the operating rights and authority granted to Inter City Courier Systems, Inc., d/b/a Quick City Delivery, Omaha, in Certificate M-13498. Notice of the application was published in The Daily Record, Omaha, on March 12, 2009. On March 17, 2009, the Commission entered an order granting temporary operating authority. No protests were filed, and the application was granted on April 28, 2009.

On March 28, 2017, the Nebraska Trucking Association notified the Transportation Department ("Department") that Applicant notified their office of their intention to not pursue their operating authority. The Department has been unsuccessful in contacting Applicant. Applicant has no vehicles, insurance or hourly rates on file.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **January 4, 2019**, the Commission will dismiss the application for failure to take timely action.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by The Billings Group, Inc. d/b/a Quick City Delivery, Omaha, in Application No. M-14207 be, and is hereby, set for **January 4, 2019**.
