OPINION AND FINDINGS

By application filed January 8, 2013, RVNB Holdings, Inc., Farmers Branch, Texas, seeks to acquire control of Kwik But Careful Movers of Omaha, Inc., Plano, Texas, holder of authority in Certificate M-14218 through purchase of stock.

Notice of the application was published in the Daily Record, Omaha, Nebraska, on March 22, 2013, pursuant to the rules of the Commission.

Because no protests were filed, Application M-14218 was processed pursuant to Rule 018.03 of the rules of procedure of the Commission.

Kwik But Careful Movers of Omaha, Inc., Plano, Texas, is a certificated carrier operating in between all points in the state of Nebraska. The business headquarters of RVNB Holdings, Inc., is in Farmers Branch, Texas.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed extended service.
2. The proposed acquisition of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application M-14218 is not dormant.

4. An order should be entered in Application M-14218 authorizing RVNB Holdings, Inc., to acquire control of Kwik But Careful Movers of Omaha, Plano, Texas, through purchase of stock.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application M-14218, be, and it is hereby, granted; and that RVNB Holdings, Inc., is hereby authorized to acquire control of Kwik But Careful Movers of Omaha, Inc., through purchase of stock as proposed by its application.

IT IS FURTHER ORDERED that following consummation of the transaction hereby authorized, RVNB Holdings, Inc., shall cause the operations of Kwik But Careful Movers of Omaha, Inc., to continue to be conducted under Certificate M-14218.


IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
