On October 15, 2018, the Commission received a Form K Insurance Cancellation Notice for Daniel's Moving and Storage of Omaha, LLC, Omaha, who holds a Certificate of Public Convenience and Necessity under Certificate No. M-14224. The Form K received from Granite State Insurance Company had a cancellation date of November 14, 2018. Daniel's Moving and Storage was notified by letter and telephone of the cancellation notice. To date, the Commission has not received a current Form H Insurance Filing.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements.

After due consideration of the circumstances, the Commission finds that Daniel's Moving and Storage of Omaha, LLC, Omaha, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to keep a current Form H insurance filing with the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Wednesday, February 20, 2018** at **11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln Nebraska.
