O P I N I O N   A N D   F I N D I N G S

On March 6, 2017, Rojoli Transportation, Inc., d/b/a Two Men and a Truck ("Rojoli"), Fairfax, Missouri, filed an application to suspend its Certificate of Public Convenience and Necessity issued in Application No. M-14225 until February 28, 2018. The request was granted on April 18, 2017. Its insurance policy cancelled on March 4, 2017.

The Commission attempted to reach Rojoli via telephone several times as the end of the suspension came nearer. On March 20, 2018, Commission staff sent a letter to Rojoli requiring Rojoli to contact the Commission about what action it wished to take regarding the certificate by March 30, 2018. No response has been received, and no current Form E insurance certificate has been filed.

After due consideration of the circumstances, the Commission finds that Rojoli Transportation, Inc., d/b/a Two Men and a Truck, Fairfax, Missouri, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to keep a current Form E insurance filing on file with the Commission. Therefore, hearing on this matter shall be held on **July 25, 2018, at 10:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
