BY THE COMMISSION:

On April 7, 2014, an application was filed by Magnificent Movers, LLC ("Applicant"), Omaha, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of household goods between all points in Nebraska over irregular routes. The Application was granted on June 10, 2014; however, Applicant never finalized its approval by filing the required fees, insurance, and rates with the Commission, nor has Applicant subscribed to the Official Household Goods Movers tariff publication from Nebraska Truck Services.

On November 1, 2016, the Commission entered an order setting a deadline of November 14, 2016 for Applicant to take action regarding this Application. Commission staff were able to speak with Applicant, and informed the company of the necessary requirements. To date, Applicant has not complied with the requirements to file its insurance, pay its vehicle fees, file its current rates, nor has subscribed to the tariff publication.

Based on the above, the Commission finds that a final deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **June 19, 2017**, the Commission will dismiss the application for failure to take timely action. Applicant must not provide any moving services or will be subject to Commission action.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Magnificent Movers, LLC, Omaha, in Application No. M-14227 be, and is hereby, set for **June 19, 2017**.
