O P I N I O N A N D F I N D I N G S

On January 8, 2018, the NST Holdings, LLC, d/b/a Aardvark Moving Company ("Aardvark"), Omaha, filed an application to suspend its authority until January 5, 2019. The Commission entered an order February 21, 2018, granting the suspension.

On January 3, 2019, Commission staff sent notice to Aardvark indicating the Suspension was ending. On or around January 18, 2019, Aardvark was sent a revocation form so that they could cancel their Certificate. Aardvark has failed to take action to either return the Certificate to compliance or to cancel the Certificate. Aardvark does not have a current Form E proof of insurance on file and has failed to register any vehicles.

After due consideration of the circumstances, the Commission finds that NST Holdings, LLC, d/b/a Aardvark Moving Company, Omaha, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to keep a current Form E insurance filing with the Commission in accordance with Commission Rule Ch. 3 §006 and failure to register a vehicle with the Commission as required in Commission Rule Ch. 3 §004.02. Therefore, hearing on this matter shall be held on **Tuesday, June 4, 2019 at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln Nebraska.
