The Nebraska Public Service Commission ("Commission"), on its own motion, hereby initiates the above-captioned docket. On March 10, 2017, Graebel/Kansas City Movers, LLC d/b/a Graebel Moving Services ("Graebel"), Lenexa, Kansas, informed the Motor Transportation Department ("Department") by telephone that it was no longer in business. The Department requested written confirmation, but has not received any written notification from Graebel. The Department has also received notification that Graebel's insurance has been cancelled.

After due consideration of the circumstances, the Commission finds that Graebel/Kansas City Movers, LLC d/b/a Graebel Moving Services, Lenexa, Kansas, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked. Therefore, hearing on this matter shall be held on **June 27, 2017 at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
