BY THE COMMISSION:

On January 2, 2018, Aksarben Enterprises, LLC ("Applicant"), Hastings, filed an Application seeking a name change to Aksarben Enterprises, LLC d/b/a Thiel Family Moving and Transport. Notice of the application was published in The Daily Record, Omaha, on January 5, 2018. On July 12, 2018, the Transportation Department was able to verify the trade name authorization from the Secretary of State's Office. No protests were filed; therefore, the application will be processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant operates as a household goods mover with a certificate of public convenience and necessity under Certificate No. M-14232. In its application, Applicant seeks an order from the Commission approving a name change to Aksarben Enterprises, LLC d/b/a Thiel Family Moving and Transport.

Upon consideration of Applicant's filing and the files and records of the Commission relative to Applicant and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant has changed its name, but no other aspect of the organization of Applicant has changed.
2. The authority held by Applicant should be carried in the files of the Commission in the new name of the Applicant to wit: Aksarben Enterprises, LLC d/b/a Thiel Family Moving and Transport, Hastings, Nebraska.
3. No further action or relief should be granted pursuant to Applicant's notification and request for official recognition of its new name.
