BY THE COMMISSION:

On August 18, 2015, an application was filed by Alexander R. Eberhardt d/b/a Black Shirt Moving ("Applicant"), Hastings, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of household goods by straight trucks and vans in Lincoln, Adams, Hall, Buffalo, Clay, Kearney, Custer, and Dawson counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. Notice of the application was published in The Daily Record, Omaha, on January 16, 2016.
