BY THE HEARING OFFICER:

On November 29, 2017, Redman Van and Storage Company ("Applicant"), Salt Lake City, Utah, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in transportation of household goods between all points in Nebraska over irregular routes. Notice of the Application was published in The Daily Record, Omaha, on December 4, 2017. The application was timely protested by Chieftain Van Lines, Lincoln Relocation, and Nebraskaland Moving. Protests were granted January 22, 2018.

On January 23, 2018, a planning conference was held to set the procedural schedule in this matter. The hearing was originally scheduled for March 21, 2018. On March 16, 2018, Mr. Andy Pollock of Rembolt Ludtke, LLP entered his appearance on behalf of Applicant. On March 16, 2018, Applicant filed a motion to continue the hearing to allow time for counsel to prepare for the hearing. On March 19, 2018, an order was issued granting the motion and continuing the hearing to a date to be determined. A telephonic planning conference was held March 21, 2018, to determine a new hearing date.

As a result of that planning conference, the parties agreed to a modified procedural schedule. I find the following amended schedule should be adopted:
