O P I N I O N A N D F I N D I N G S

On November 29, 2017, Redman Van and Storage Company ("Applicant"), Salt Lake City, Utah, filed an application seeking authority as a common carrier to transport household goods between all points in Nebraska over irregular routes. Notice of the Application was published in The Daily Record, Omaha, on December 24, 2017. The application was timely protested by Chieftain Van Lines, Lincoln Relocation, and Nebraskaland Moving (collectively Protestants).

On April 24, 2018, the Applicant filed a motion to amend its application. The amended application would restrict Applicant to only providing moving services booked and billed through other agents of North American Van Lines or Allied Van Lines. A Hearing Officer's Order was entered May 1, 2018, granting this amendment. The Applicant amended its application as follows:

AUTHORITY SOUGHT

Common Carrier providing transportation of household goods between all points in Nebraska over irregular routes limited to moves booked and billed through other agents of North American Van Lines or Allied Van Lines.

On May 1, 2018, the hearing officer entered an order granting the withdrawal of all Protestants. The Application was then processed pursuant to Rule 018.03 of the Commission Rules of Procedure.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service, and to conform to the provisions of NEB. REV. STAT. §§ 75-301 to 75-322 (Cum. Supp. 2016) and

the requirements, rules and regulations of the Commission thereunder.

2. Upon compliance with NEB. REV. STAT. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2016), and with the rules and regulations of the Commission, a Certificate of Public Convenience and Necessity should be issued as proposed:

CERTIFICATE AUTHORIZED

Common Carrier providing transportation of household goods between all points in Nebraska over irregular routes limited to moves booked and billed through other agents of North American Van Lines or Allied Van Lines.

3. The application for authority should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. M-14245 be, and it is hereby, granted as amended; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Redman Van and Storage, Salt Lake City, Utah, in Application No. M-14245, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with NEB. REV. STAT. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Cum. Supp. 2016), and with the rules and regulations of the Commission, and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the operations authorized herein shall be subject to the terms, conditions, and limitations which have been, or may hereafter be prescribed by the Commission.
