COMES NOW Robert R. Logsdon, complainant in the above-captioned cause, pursuant to Neb. Rev. Stat. Section 75-322.02 (1990 Reissue), and for complaint against Special Dispatch of Omaha, Inc. (Special Dispatch), defendant, alleges as follows:

- 1. Complainant is the Director of the Transportation Department of the Nebraska Public Service Commission (Commission) and is the custodian of the Commission's Motor Transportation Department documents and records.
- 2. Defendant, Special Dispatch, is a motor carrier conducting for-hire intrastate motor carriage in the State of Nebraska. The Commission's records and documents show that defendant has a permit of authority (M-13005) issued from the Commission to operate as a contract carrier as follows:

CONTRACT: Paper, paper products, cardboard, cardboard products, boxes, and packaging material as used in the conduct and operation of Crown Packaging Corporation's business between its warehouse in Omaha and all points in Nebraska within a 150-mile radius of Omaha over irregular routes under continuing contract(s) with Crown Packaging Corporation. SUPP. NO. 1:

Medical and hospital supplies (not to include blood, plasma, or laboratory specimens) between points in Nebraska over irregular routes under continuing contract(s) with Abbott Laboratories. SUPP. NO. 2: General commodities (except those requiring special equipment) between points within a 200-mile radius of Omaha over irregular routes under continuing contracts with Bennett Business Forms, Air Management Supply, Inc., and Central Mattress, Inc.

3. On or about the following dates, defendant violated Section 75-309 of the Nebraska statutes, as amended, for operating as a common carrier without a certificate of authority having been issued by the Commission authorizing the particular operations specifically listed below:

4. On or about the following dates, defendant violated Section 75-304.01 of the Nebraska statutes, as amended, for demanding, charging, or collecting less compensation for such transportation than the charges to be made by common carriers for the same transportation in accordance with Chapter 75, article 3, as affected by any rule, regulation, or practice so filed, or as may be prescribed by the Commission. The following bills were found to be in violation for charging less than the applicable tariff rate approved by the Commission:

- 5. The shipments listed above in Paragraph 3, which were in violation of Neb. Rev. Stat. Section 75-309, represent a combined revenue of \$1,509.30. The shipments listed above in Paragraph 4, which were in violation of Neb. Rev. Stat. Section 75-304.01, collectively represent a total undercharge of \$711.20.
- 6. On or about November 30, 1992, complainant filed Motor Carrier Complaint MCC-3068 against defendant for violation of Neb. Rev. Stat. Section 75-309, as amended, for operating as a common carrier without authority. Said complaint was subsequently dismissed as satisfied on February 2, 1993, upon payment of a civil penalty by defendant in the amount of \$300.00.

WHEREFORE, complainant prays the Commission for an order levying a civil penalty against the defendant pursuant to Neb. Rev. Stat. Section 75-322.02, as amended, and Title 291, Chapter 1, Rule 027.02 of the Nebraska Administration Code in an amount not less than two thousand dollars (\$2,000.00) and any other order the Commission deems appropriate and which is within its jurisdiction to render, including, but not limited to, an order that the defendant cease and desist from further operating outside its granted contract authority and from failing to obey the terms of the applicable tariffs.
