Robert R. Logsdon, Director, Transportation Department, Nebraska Public Service Commission, for his complaint against the defendant alleges:

I.

The Nebraska Public Service Commission issued a Certificate of Public Convenience and Necessity to the defendant on May 27, 1994, and defendant's 1997 annual fees became delinquent on March 1, 1997.

II.

That on February 13, 1997, a delinquency notice was sent to the defendant requesting compliance by March 13, 1997, and warning that a departmental complaint could be issued if defendant failed to comply by that date. Defendant did not comply.

III.

That the defendant willfully failed to pay an annual fee for each vehicle operated in 1997 as required by Section 75-305, R.R.S. 1943, as amended, and Title 291, Chapter 3, Rule 004 et. seq. of the Nebraska Public Service Commission's Motor Carrier Rules and Regulations.

WHEREFORE, complainant prays the Commission for an order levying a civil penalty against defendant pursuant to Section 75-322.02 R.R.S. 1943, as amended, and Title 291, Chapter 1, Rule 027.02, in an amount not less than forty dollars (\$40.00), and for an order suspending, changing or revoking the Certificate of Public Convenience and Necessity issued to the defendant, and any other order the Commission deems appropriate and which is within its jurisdiction to render.
