BY THE COMMISSION:

On July 11, 2017, Jamie Reyes, Director of the Motor Transportation Department (Complainant) filed a complaint against the above-captioned Respondent alleging violation of NEB. REV. STAT. § 75-307 (Cum. Supp. 2016). Complainant alleges that Respondent failed to maintain proper insurance as required by § 75-307. Said insurance lapsed June 21, 2017. Respondent is a motor carrier as defined by § 75-302(13) and is subject to Commission rules and regulations. Complainant seeks an order revoking Respondent's Certificate of Public Convenience and Necessity and to require Respondent to cease and desist from offering services as motor carriers pursuant to § 75-133, and/or to assess any such fines authorized by law for failure to maintain proper insurance in compliance with § 75-307.

The Commission finds that a copy of the Complaint and this Order shall be mailed to each Respondent via certified mail.

The Commission further finds that Respondent should be ordered to show cause as to why the Commission should not revoke Respondent's Certificates of Public Convenience and Necessity and order Respondent to cease and desist from offering services as a motor carrier in Nebraska pursuant to § 75-133, and/or order an assessment of administrative fines for failure to maintain proper insurance in accordance with § 75-307.

Finally, the Commission finds that a hearing on this matter should be scheduled for **Wednesday, September 6, 2017, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.

REV. STAT. § 75-133, and/or order that Respondents remit any such fines authorized by law for failure to maintain proper insurance in accordance with NEB. REV. STAT. § 75-307.

IT IS FURTHER ORDERED that a copy of the Complaint and this Order shall be mailed to the Respondent via certified mail.

IT IS FINALLY ORDERED that a hearing on this matter is scheduled for **Wednesday, September 6, 2017, at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
