BY THE COMMISSION:

Upon the complaint of Jamie L. Reyes, Director of the Motor Transportation Department, D&N Event Center ("D&N" or "Respondent") is alleged to have violated Neb. Rev. Stat. §§ 75-126, 75-305, 75-307, 75-309 and 291 Neb. Admin. Code Ch. 3 by providing intrastate passenger transportation services for hire without Commission authorization, without proper insurance, proper vehicle registration and licensure, and unauthorized rates on May 4, 2018.

In consideration of the Complaint filed herein, the Commission is of the opinion and finds that D&N Event Center should be required to appear before the Commission on **April 16, 2019 at 11:00 a.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska, to show cause as to why it should not be assessed civil penalties for operating as a motor carrier without a Certificate of Public Convenience and Necessity or Permit of Authority, proper insurance, properly licensed and registered vehicles, and utilizing unauthorized rates and failing to comply with Commission Rules and Regulations.

cause as to why Respondent should not be assessed civil penalties for violating Commission Rules and Regulations and operating as a motor carrier without a Certificate of Public Convenience and Necessity or Permit of Authority, proper insurance, properly licensed and registered vehicles, and utilizing unauthorized rates.
