By Order entered December 9, 2003, the Nebraska Public Service Commission released for comment a proposed affidavit form to be used in its yearly rate review with respect to regulated household good movers. Comments were due on or before January 9, 2004. No comments were filed.

consideration of proposed affidavit the Upon administratively noting that there has been no opposition to it filed, the Commission is of the opinion and finds that the proposed affidavit should be adopted. The Commission finds that attached affidavit form should be mailed out certificated household goods movers in the State of Nebraska. Going forward, the Commission will initiate this process on a yearly basis. For a 2004 adjustment, regulated household goods movers have until March 12, 2004 to return their affidavits back to the Commission in order to include such information into the Commission's record for consideration. Based upon the number of responses and the information received by the Commission, the Commission may decide to set the matter for hearing and adjust the tariff accordingly.

- IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the affidavit form attached hereto be and it is hereby officially adopted.
- IT IS FURTHER ORDERED that interested household goods movers have until March 12, 2004 to file completed affidavits in order to obtain Commission consideration for a 2004 rate adjustment.
