## BY THE COMMISSION:

On May 8, 2018, the Nebraska Public Service Commission (Commission), on its own motion, initiated this investigation to investigate and establish reasonable rates and charges for Goods Movers. The Commission had previously established an annual review process to determine whether any adjustment is to be made in the household goods movers Tariffs 7F and 22. The Transportation Department undertook a larger review of the Tariffs this year. To facilitate that review, this docket and Docket MR-1021/PI-210 were opened. For the 2018 review, this docket serves to evaluate the adjustments to rates. The Commission's May 8, 2018 order also set this matter for hearing on May 30, 2018. Notice of the hearing was published in The Daily Record, Omaha, Nebraska, on May 10, 2018.

On July 31, 2018, the Commission entered an order granting a seven percent increase to the hourly labor and line haul rates. Subsequently, several carriers contacted the Commission with concerns about this increase, particularly as it relates to the Tariff 7F Local Rates. Additionally, some questions were raised about the language relating to gift cards.

Based upon the concerns and questions raised by carriers, the Commission finds that an additional hearing is necessary at this time. Such hearing will be held **Tuesday**, **September 18**, **2018 at 1:30 p.m.** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln Nebraska.
