BY THE COMMISSION:

On January 28, 2003, the Commission opened Docket MR-1009/PI-70 to investigate range uniformity in the Official Household Goods Movers Tariff 22, and to develop procedures for efficiently processing household goods mover tariff amendments in the Tariffs 7F and 22. Since that time, the Commission has held hearings to determine changes to the tariff and rate increases for the movers. The Commission established an annual review process to determine whether any adjustment is to be made in the household goods movers Tariffs 7F and 22. On December 19, 2017, the Commission entered an order postponing that schedule. A hearing was held May 23, 2017, to discuss changes to the rate. No increase was made at that time. However, the Transportation Department indicated changes to the tariff were being considered.

To facilitate discussion for changes to the Tariff, Docket No. MR 1021/PI 210 was opened. Workshops have been held November 7, 2017, January 30, 2018, and February 28, 2018. Members of the industry submitted comments and participated in discussion regarding substantial changes to the Household Goods Movers Tariff 7F and Tariff 22. A hearing is scheduled in that matter for May 16, 2018. The hearing will address changes to the substance of the Tariffs. Through these proceedings, it became clear that rates would need to be addressed separately.

The Commission therefore opens this docket to determine any necessary adjustments to the rate structures set forth in the Tariffs. The Commission finds that a hearing shall be held **May 30, 2018 at 1:30 PM** in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska.
