BY THE COMMISSION:

The Nebraska Public Service Commission (Commission), on its own motion, initiates this proceeding to investigate transportation services provided by certificated carriers in the state of Nebraska. In this investigation, the Commission seeks to explore facets of the transportation service provided in and around the state of Nebraska.

In hearings before the Commission, in particular Docket B-1829, Golden Plains Services Transportation, d/b/a GPS Transportation, the Commission received evidence about GPS regarding a number of complaints that were filed with Intelliride regarding the services provided by GPS. The Commission is concerned that those type of complaints also exist concerning the operations of other transportation providers across Nebraska.

The Transportation Department should conduct an examination of the situation involving the issues set forth below. The Department should inquire of organizations such as the Nebraska Department of Health and Human Services, Intelliride and agencies such as areas on aging inquiring as to their experiences with the provision of transportation services. The Department should also seek out comments from any interested parties that may be able to provide input on the subject of this investigation.

Interested parties should file comments regarding the issues listed herein on or before **August 31, 2015**. Parties should file one (1) original paper copy, and one (1) electronic copy with the Commission in Microsoft Word format. Electronic copies should be sent to mark.breiner@nebraska.gov.


