OPINION AND FINDINGS

On June 16, 2015, the Nebraska Public Service Commission (Commission) opened the above-captioned docket, on its own motion, to establish interim policies for the implementation of LB 629 [2015] pending final rulemaking. In the Order opening the docket, the Commission adopted temporary procedures and forms related to the application for permit to operate as a transportation network company (TNC) in Nebraska, and the lienholder notification required by drivers who plan to use their personal vehicles that have a lien to provide transportation services with a TNC.

On August 5, 2015, a workshop was held to discuss comments received regarding the first set of proposed rules and regulations for TNCs released on June 16, 2015.¹ During the workshop, the parties discussed the lienholder notification requirement and the temporary form and procedures adopted in the June 16, 2015, Order in the present docket. Discussion included the possibility of implementing electronic filing of lienholder forms, what documents constitute acceptable proof of receipt from the lienholder, and whether notarization of the forms should be required.

Subsequent to the hearing, the Commission released a second set of proposed rules which made modifications to sections related to lienholder notification forms.² Specifically, the second proposed rules eliminated the requirement that lienholder forms be notarized, and required that the driver file a copy of

the signed form and proof of receipt with the Commission prior to providing transportation service in connection with a ${\rm TNC.}^3$

Based on the discussions during the August 5, 2015, workshop and the changes adopted in the proposed rulemaking, the Commission finds that the temporary policy and form for lienholder notifications should be amended as follows:

- 1. Lienholder forms are required in the following instances:
 - a. New drivers to the TNC platform that have a lien on the vehicle to be used in connection with providing transportation services for the TNC;
 - b. Existing drivers on the TNC platform that acquire a lien on a vehicle to be used in connection with providing transportation services for the TNC; and
 - c. Any driver on the TNC platform that has filed a lienholder form and changes lienholders during the course of his or her employment as a driver with a TNC.
- 2. Lienholder notification forms must be signed by the driver, but do not need to be notarized prior to filing the form with the lienholder.
- 3. Acceptable proof of receipt of the lienholder form can be the original certified mail return receipt from the United States Postal Service or a certified letter from the lienholder institution.

The updated lienholder notification form, attached as Appendix A, should be approved. The updated lienholder notification form will be available for immediate use.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the amended policy and form proposed by Commission staff, attached hereto as Appendix A, is hereby approved.

LIENHOLDER NOTIFICATION FORM Filing Procedure

- 1. All potential drivers for a transportation network company seeking to use a personal vehicle with a lien must submit a lienholder notification form as approved by the Nebraska Public Service Commission.
- 2. Drivers should download a lienholder notification form from the Nebraska Public Service Commission website: http://psc.nebraska.gov for use.
- 3. Lienholder notification forms must be completed by the intended driver and submitted to the driver's lienholder, such as a financial institution or individual. The driver must file the lienholder notification form with the lienholder no later than seven (7) days prior to providing transportation services in connection with a transportation network company.
- 4. The driver must file a copy of the completed lienholder notification form and proof of receipt from the lienholder by mail or by personal delivery to: Nebraska Public Service Commission, 1200 N Street, Ste. 300, Lincoln, NE 68508 or P.O. Box 94927, Lincoln, NE 68509-4927. Acceptable Proof of Receipt may be (i) the original certified mail return receipt or (ii) a signed, certified letter from the lienholder verifying receipt of the lienholder form from the driver.
