BY THE COMMISSION:

On May 11, 2004, an Order was entered in this matter granting in part and denying in part the application filed by Safeway Cabs, Inc., of Omaha, Nebraska. By inadvertence, a copy of this Order was not sent to Happy Cab, Cornhusker Cab, Checker Cab, Yellow Cab and Metro Cab, all of Omaha, Nebraska.

Consequently, Happy Cab, Cornhusker Cab, Checker Cab, Yellow Cab and Metro Cab did not have the correct waiting time amount for the taximeter test performed during the week of May 17, 2004. The taximeters need to be reset with the new waiting time amount.

Taximeters are to be tested, approved and sealed by a representative of the Commission. During the week of May 17, 2004, all taximeters were tested, passed and sealed pursuant to Commission Rules and Regulations. The taximeters of Happy Cab, Cornhusker Cab, Checker Cab, Yellow Cab and Metro Cab need to be unsealed, adjusted for the new waiting time amount, and resealed.

The Commission finds, pursuant to Rules 011.01F1 and 011.01F2, that Mr. Daniel Deveney, a manager of Happy Cab, is a representative of the companies that should be authorized to unseal, adjust and reseal the taximeters of Happy Cab, Cornhusker Cab, Checker Cab, Yellow Cab and Metro Cab subject to the following terms and conditions:

That this authorization is effective for a period of time that commences on Wednesday, June 30, 2004, and terminates on July 16, 2004.

That Mr. Deveney is authorized to adjust only for the waiting time, and is not authorized to change any other factor in the taximeter.

That Mr. Deveney will certify to the Commission that he has adjusted the taximeters pursuant to this Order, and will file a verified report of the taximeters adjusted.

That this Order applies only to taximeters that were sealed at the taximeter course testing performed during the week of May 17, 2004. Any new and/or additional taximeters not sealed during that week must be inspected, tested, approved and sealed by the Investigator of the Commission.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that The Commission finds that Mr. Deveney, of Happy Cab, is a representative of the companies and is hereby authorized to unseal, adjust and reseal the taximeters of Happy Cab, Cornhusker Cab, Checker Cab, Yellow Cab and Metro Cab under the following terms and conditions:

That this authorization is effective for a period of time that commences on Wednesday, June 30, 2004, and terminates July 16, 2004.

That Mr. Deveney is authorized to adjust only for the waiting time, and is not authorized to change any other factor in the taximeter.




That Mr. Deveney will certify to the Commission that he has adjusted the taximeters pursuant to this Order, and will file a verified report of the taximeters adjusted.


