OPINION AND FINDINGS

On December 30, 2003, Spencer M. Fentress, d/b/a Fairbury Taxi, of Fairbury, Nebraska, filed an application for authority to amend its taxi rates for its use as follows:

Description	Proposed Rate
1. Inside Fairbury City Limits	
a. One way trip	\$2.50
b. One way trip-Seniors	\$2.00
c. Each additional passenger	\$0.50
d. HHS One way trip	\$2.50
e. HHS One way trip Seniors	\$1.50
2. Outside Fairbury City limits	
a. Per/mile	\$1.00
b. Per/mile Seniors	\$0.80
c. Per/mile HHS	\$1.00
3. Hours are 24 hours/day, 7 days/week, with only prearranged service on major holidays	
4. Scheduled and advanced appointments are accepted.	
5. Persons using wheelchair will be served with only minimal assistance in and out of cab.	
6. Children of ages six and up will be served unaccompanied by an adult and will be escorted to the door, if needed. Younger children must be accompanied by an adult, at no extra charge. If needed, car seats will be available and should be requested at the time of the call.	
7. Out of town service will be provided to Thayer and Gage counties, as authorized, with HHS restricted to 5 mile radius of Fairbury.

8. Discount in town rides will be sold at the rate of:
 - a. 10 in town one way trips..... \$20.00
 - b. 10 in town one way trips seniors..... \$15.00
 - c. 20 in town one way trips..... \$40.00
 - d. 20 in town one way trips seniors..... \$30.00

Due to the transfer of the duties and responsibilities within the Commission, the application was misplaced. The applicant's request for the emergency is that the proposed rates can be placed into effect immediately.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis.


