BY THE COMMISSION:

On November 21, 2005, Servant Cab Company LLC (Servant or Applicant), of Lincoln, Nebraska, filed an application for authority to increase its taxi rates between points in Lincoln and a 25 mile radius thereof. A portion of that proposed rate increase was to change the then-current rate of \$2.40 for the first one-tenth of a mile to \$2.40 for the first one-thirteenth of a mile. The publication notice inadvertently showed the proposed rate to be \$2.00 for the first one-thirteenth of a mile. After a hearing on February 23, 2006, the rates were approved as published by the Commission without any party finding or correcting the inadvertent error in the published rate.

The result of the error in the publication notice and the resultant rate as granted is a reduction in the amount of increase sought by the Applicant in this matter that would adversely affect the Applicant. Because the error was one in which the rate under consideration here as published was less than the rate approved, the rate under consideration in this order must either be republished or approved on an emergency basis. The Commission finds that this circumstance is one in which it can and should exercise its authority under Nebraska Revised Stature Section 75-121 regarding emergency rte orders.

The Commission finds that the rate set forth below is reasonable under the circumstances. The Commission finds that the rate as set forth below should be approved on an emergency basis and set with an effective date the same as that approved by this Commission previously.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the rate as set forth below should be granted on an emergency basis effective March 31, 2006.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that effective March 31, 2006, Servant Cab Company LLC, Lincoln, Nebraska, be, and is hereby, authorized to increase its taxi rates between points in Lincoln and a 25 mile radius thereof as follows:

First one-thirteenth of a mile	\$2.40

All other rates as approved by the Commission on March 14, 2006, are to remain in full force and effect.

IT IS FURTHER ORDERED by the Nebraska Public Service that notice of this amendment to their rates be conspicuously displayed within each taxicab.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission that public notice of this action be published in the <u>Daily Record</u>, Omaha, Nebraska, pursuant to the provisions of Section 75-121. R.R.S. 2003, and the Commissions Rules.
