### OPINION AND FINDINGS

On April 26, 2006, Daniel W. and Susan L. Sindt d/b/a Kearney Cab Company, Kearney, Nebraska, filed an application for authority to amend its rates for its operations as follows:

Description	Current	Proposed
1. First 1/5 mile (initial meter charge)	\$2.50	\$2.75
2. Each additional 1/5 mile or fraction thereof	\$0.30	\$0.35
3. Each additional passenger and/or baggage	\$0.75	\$0.75
4. Waiting time per minute	\$0.30	\$0.30
5. Refusal of ordered service upon arrival of taxicab at point of commencement of trip.	\$2.25	\$2.25

Emergency action is requested.

Applicant is a certificated common carrier which holds Certificate B-1402. The certificate authorizes the transportation of passengers by taxicab between points in Buffalo County and between points within Buffalo County, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized.

In support of the application, Daniel Sindt of Kearney Cab states that fuel charges have increased dramatically. Prices in his area have increased to \$2.90 per gallon in the last few weeks. This increase in the cost of gasoline is having a negative effect on the Applicant's ability to provide service.

At the time of the last rate increase for the Applicant in March of 2005 it was noted that the cost of gasoline had reached nearly \$2.10 per gallon average in Nebraska. The average cost of fuel in Nebraska as of the time of this order is now around \$2.90, which is a thirty-eight percent increase. The increase in the rate requested by the Applicant is ten percent on the initial meter charge and sixteen percent in the mileage charge. These charges as proposed by the Applicant are still competitive with rates charged by other companies providing similar services.

The increase in cost to the applicant is significant, and needs to be addressed quickly to protect the applicant's ability to continue

to provide its services to the public. The Commission finds that the proposed rates are reasonable, and the increases in the rates are justified due to the thirty-eight percent increase in the cost of gasoline and are necessary for the Applicant to continue to provide and improve its services to the public.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective May 5, 2006.

## ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective May 5, 2006, Daniel W. and Susan L. Sindt d/b/a Kearney Cab, Kearney, Nebraska, be, and it is hereby, authorized to amend its rates for its use in Certificate No. B-1402 as follows:

Description	Rate
1. First 1/5 mile (initial meter charge)	\$2.75
2. Each additional 1/5 mile or fraction thereof	\$0.35
3. Each additional passenger and/or baggage	\$0.75
4. Waiting time per minute	\$0.30
5. Refusal of ordered service upon arrival of taxicab at point of commencement of trip.	\$2.25



IT IS FURTHER ORDERED by the Nebraska Public Service Commission that notice of this amendment to their rates be conspicuously displayed within each taxicab.
